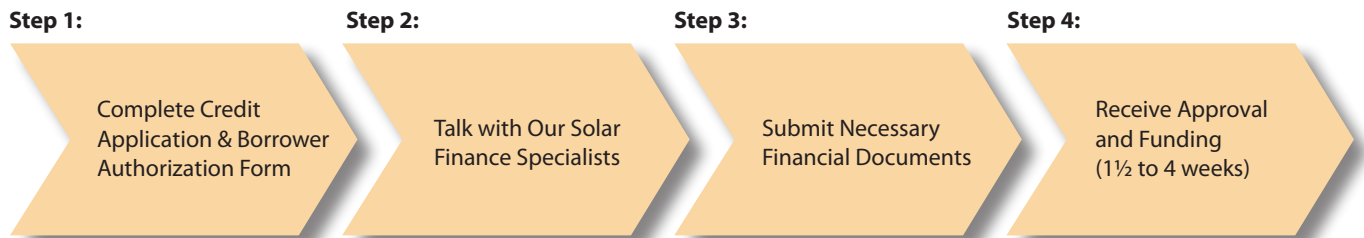

Credit Application: This information will help our solar finance specialists narrow down the financing options to find the best solution for your situation.

Borrower Authorization Form: This form will allow our specialists to evaluate your credit report to determine the financing solutions available to you.

Step 3: Submit Necessary Financial Documents

Our solar finance specialists will require the following documents:

- Credit report (this can be obtained by sending in a signed Borrower Authorization Form)
- Copy of current mortgage statements
- Copy of current driver's license or government issued ID (all borrowers)

Depending on the loan products and your current situation, the following may be required:

- Income documents: recent pay stubs, W-2 statements, 1040's, etc.
- Asset documents: recent statements for bank and investment accounts, etc.
- Miscellaneous documents: copy of insurance coverage, etc.

Step 4: Receive Approval and Funding

In most cases, the loan will be funded in 1½ to 4 weeks after the documents have been submitted to the solar finance specialists.
